- 6. Communications
 - a. Mindy and Joy meet with Clay learned asking him to be our buyer's agent. Clay's discussed that his first move was to identify potential properties, even if those properties are not on the market today. Clay was confident that he could convince the property owners to sell even their property was not on the market. Clay normally charges a \$300 per hour rate, but was proposing a \$150 / hour rate for us and that this rate would be debited against any commission on the sale (he wants to be the seller's agent as well), so that he would in essence not be paid twice. Clay will write this all up and give us a formal contract. What Clay needs from us is a financial threshold in the meeting so that he can

- begin to hire some consultants he will need in the pursuit of property search.
- b. Lynn asked how much of a threshold he was looking for.
- c. Chis said we should text Clay for clarification. Mindy then sent a text to Clay asking for what he was looking for as a threshold.
- d. Joy, we were also contacted by the Church in Clear Lake. Joy indicated they should contact Clay.
- e. Joy asked Mary Alice to see if she had an idea of how much a consultant charges. Mary Alice indicated that it really depends, and believes we need to have a ceiling and that we really should have a contract.
- f. Mindy suggested that we cap this at \$5000 for example and then can amend that amount what some of the consultants will run.
- g. Mary Alice said we should have a proposal with hourly rates, and all the details.
- h. Motion:
 - i. Mary Alice moves that in advance of receiving a proposal and contract for Mr. Clay Learned be authorized to conduct a property search on behave of the Central Rural Partial County Library District at \$150 / hour and has authority to conduct a property search on our behalf at a rate of \$5000 towards the payment of sub-consultants through the end of July.

7. Report of the Director

- a. Joy was talking to the Sersi rep and they wanted us to purchase an upgrade for \$5000 to bump us up to a 50,000 circulation count. This payment of \$5000 also had an additional annual support charge of \$2060 for year 1, \$2140 for year 2 and \$2200 for year 3.

- c. Today we have paid \$12,000 but our circulation is limited to 7500.
- d. Today our rate is \$4,650 / year.

- g. Lynn said we need to make the system work, before we give them some more money.
- h. Chris wanted to get Jeanne's opinion.
- Jeanne said that she doesn't believe there is a hurry and has never paid what she was initially quoted. Our annual maintenance fee today is really low.
- Joy will tell Sirsi that we will wait for any upgrade until we get our existing access fixed.
- k. Joy said the new website is up and running and looks good.
- Ahmik concurred.
- m. Joy had a good discussion with the writers group.
- n. Joy indicated that Project Homeless Connect is Sept 11 from 9 am 2 pm and we will have a booth setup for this event. This event is really important, as the people are showing up looking for services that we could offer. Joy stipulated that she will need help staffing the booth and

several other board members indicated their support as well.

- 8. Mindy received clarification from Clay via text clarifying the maximum he would need and Mindy read this out loud: "At this point I would say \$3000 would be the maximum. If it goes over that, or it is thought it might, it would need to come back to the board for a specific action for the particular purpose." -- Clay
