C. New Library Update (Information)

Mary Alice Grobins shared that the \$1.5M budget appropriation had been approved by state legislators. She also apprised the Board of the retention of Roger Howard to consult during design and construction. The team has been working on getting a budget in place and hopes to be able to share this by next regular meeting. There are plans in place to hold two joint meetings with Sedro-Woolley City Council after schematic design. This will then kick off design development, where another joint meeting will be held closer to the end of the project.

10. New Business

A. Reciprocal Borrowing

The City of Burlington provided the Board with a signed Interlocal Agreement for reciprocal borrowing between the libraries. The Director explained that this agreement was the same in content as the other interlocal agreements with the other libraries in Skagit County.

Jeanne Williams shared that the pursuit of reciprocal borrowing privileges with the City of Mount Vernon is being worked on internally. She let the Mount Vernon Library Director know that the Board would be glad to speak with library and city administration as this process moves forward.

B. Collections (E)

Jeanne Williams shared with the Board that the procedure for handling patrons with long overdue items at the Sedro-Woolley Public Library had been to send those patrons to a collection agency. Thus far, this had not been the practice of the Central Skagit Library District. Jeanne Williams asked the Board for direction with regard to sending patrons to collections. She shared that currently, patrons with long overdue materials are blocked from checking out library materials and are blocked from most of the digital services. The Board discussed the library's focus on building relationships,

and felt that collections activities could be damaging to that endeavor. The Board concluded that the loss rate should be monitored and, if the Director felt that it was becoming a large enough issue, using collections could be discussed at that time.

11. Other Business

Jeanne Williams will be out on sick leave beginning on April 27, 2018 to last approximately 10 days.
