7. Report of the Director (attached to previous meeting materials)

Jeanne Williams further shared that library hours will be changing so that patrons have more hours to be able to visit the library: Monday-Thursday 10am to 8pm, Friday and Saturday 10am to 5pm. This will also standardize open hours with most of the Skagit libraries. This is in preparation for the hours and scheduling of multiple desks in the new library so that staffing concerns may be addressed well before the new library opens.

Jeanne Williams talked about a new self-check system called MeeScan, which allows for both check-out at a kiosk or on one's smartphone.

Jeanne Williams also updated the Board on the challenges of security camera placement in the building due to the beam structure.

The Bookmobile will be going to the Overlook Golf Course on Wednesdays throughout the summer.

Jeanne Williams shared her activities of the month. One item she highlighted was her attendance at the Evergreen Symposium in Vancouver, WA. This event allowed the Director to learn from other librarians in Washington and Oregon who use the Evergreen library automation system. The system is an open source system with powerful data retrieval and a level of customization not available in other systems. There are special settings that could potentially increase efficiency when using the system. Ultimately, the circulation module is very similar to the circulation module currently being used by the staff. However, reporting and cataloging modules would require more assessment. Regardless of the learning curve, all of the Skagit Directors value the opportunity to share one library automation system to facility interlibrary loan among the Skagit libraries to provide more seamless service to the patrons. It would eliminate the need to issue separate cards for every library for reciprocal patrons. The pricing is forthcoming but is expected to be below the cost of the current automation system.

Jeanne Williams shared to be on the lookout when visiting City Hall for the scrolling marquee of library events in the main entrance.

Mary Alice Grobins asked if the security cameras would be monitored; if they will be recorded; and who would have access to the recordings.

Jeanne Williams replied that an outside vendor would not be doing real-time monitoring, but that on-duty staff would have access to a live stream so that activities could be monitored by staff from a central point. The footage will be recorded on the library's network and server, with about 90 days of footage archived. The only person considered for access to the footage would be the Library Director but a secondary should be considered for the future.

Mary Alice Grobins asked if there had been an entrance interview for the audit. Jeanne Williams shared that this year's audit would only be a report filing rather than a full desk audit. Mary Alice Grobins clarified that every second year would be a desk audit but that every year is audited.

Mary Alice Grobins shared that the advantages of moving to the Evergreen ILS would provide the libraries involved with more options for people to move among the libraries and moving materials among the libraries. Jeanne Williams shared that this understanding is correct and that it would also negate the need for patrons to apply for separate library cards for each library. It would also allow for the implementation of a system to courier materials among libraries rather than asking patrons to do the travel.

8. Unfinished Business

A. New Library Project Update

Jeanne Williams updated the Board by pointing out that the utility poles had been relocated away from the library building site. She furthered that the construction bid documents had gone live on the city website on Monday. She also reminded everyone that the groundbreaking ceremony would be on June 5 at 2:00pm.

Mary Alice Grobins clarified that the bid opening date had changed from May 10^{th} (as listed in the report) to May 22^{nd} at 2:00pm after a meeting with the architects earlier that day. Other items were also altered to invite more contractors to bid the project. Some of these changes included the extension of time to prepare bids. Mary Alice Grobins also shared that the groundbreaking should not be affected unless the bids were to come in too high.

Mary Alice Grobins further shared that, during a bid period, addenda may be put out based on comments, questions or requests for clarification. She furthered that on the upcoming Monday, April 22nd, an addendum would be released that would allow the contractors flexibility up to 90 days in the start date of the project. These things have been done because the large amount of construction in the area and the competition for sub-contractors.

The legislature has not released a budget, but the hope is that it will be released by sine die (April 28th).

B. First Amendment to Library Partnership ILA with the City of Sedro-Woolley (Appendix 1)

Mary Alice Grobins explained that this amendment allows for the specific date for the financing. This is the second time this has been before the Board and called for a decision.

E. Logo/Branding Options for Future Community Input

Jeanne Williams shared that the Board had recently reviewed logos that would be a complete departure from the current logo. After some discussion of a tune-up of the current logo to go out with the new logo as a community input event for future branding, Jeanne Williams engaged the Aaron Logue to make some changes to the current logo. The second set of logos reflect alterations to the current logo and then his recommendation of the two logos to gather community input on. She pointed out that the fonts for all of the logos are the same so that the design of internal signage could be created.

Mary Alice Grobins shared that she felt it was important for the Board to make decisions about the library naming convention before settling on the final branding. She proposed that it would be an appropriate discussion for the Board Retreat. She said that she is troubled by the library name having five or six words in it.

Mindy Coslor shared that she didn't feel that it needed to be hurried. Trustees agreed.

Jeanne Williams will provide examples of naming options in the Board Retreat materials.

9. New Business

A. Election of Officers (D)

Mary Alice Grobins opened the floor for nominations. She furthered that it might be a good idea to create a formal process for future elections since one currently does not exist.

Mindy Coslor nominated Mary Alice Grobins for Board Chair. Lynn Torset seconded this nomination. The Board voted to unanimously elect Mary Alice Grobins as Chair.

Mary Alice Grobins happily accepted the position but shared that she would like for the Board to understand that she does not expect to be Chair for life but does understand that it could be helpful to continue to fulfill this role during the construction of the new library. She furthered that should could also serve as a liaison to the city during construction process if she was not Chair. She further shared that, in the future when construction concludes, it might be a more favorable work load for someone who still works full time.

Lynn Torset nominated Timothy Howland to be Vice Chair.

Darcy Resetar seconded this nomination.

The Board voted unanimously to elect Timothy Howland as Vice Chair.

B. 2019 Director's Contract (Appendix 3)

Mary Alice Grobins shared that this should have been done at the beginning of the year after the evaluation process.

Mary Alice Grobins alerted the Board to be on the lookout for an email from Jeanne Williams with the discussion items for the Board Retreat on June 1st and a copy of the agenda from the 2018 retreat as a refresher. Trustees were asked to submit any other topics to Jeanne Williams as soon as possible so that meetings with the facilitator Catherine McHugh could include all pertinent topics.

Mary Alice Grobins shared that she would like to try to get a representative from the Department of Natural Resources to come and provide a presentation to the Board about the timber revenues. She shared that Trustees need to understand the timber revenues because they are currently not depended upon for operations because they are not predictable. However, at some point some of that revenue may have to be dialed into the budget rather than being held apart as windfall funds.

Mary Alice Grobins also pointed out that it would be a good idea to also have someone from the Tax Assessor's Office come and present tax revenues to the Board since there are two new Trustees.

Mary Alice Grobins reminded everyone to check email and get back to the Director on agenda topics or any items that may come up.

FIRST AMENDMENT TO THE BUILDING JOINT DEVELOPMENT AND OWNERSHIP AGREEMENT

This First Amendment to the Building Joint Development and Ownership Agreement ("Agreement") is by and between the City of Sedro-Woolley ("City") and the Central Skagit Rural Partial County Library District ("District"), pursuant to RCW Chapters 27.12 and 39.34.

RECITALS

- A. The City and the District are parties to a series of interlocal agreements addressing the construction, ownership and provisioning of services at the New Library;
- B. The Building Joint Development and Ownership Agreement dated July 20, 2017 includes a provision in Paragraph 7 that references general timeframes and that Paragraph is now ready to be refined with specific dates.

NOW, THEREFORE, in consideration of the foregoing, the parties agree and contract as follows:

AMENDMENT AGREEMENT

A. Paragraph 7 of the Agreement is amended to read as follows:

LIBRARY CONSTRUCTION FUND. For the period of time between the Effective Date of this Agreement and the December prior to the year in which the first debt service payment is due on the Bonds September 30, 2019, the City and the District agree to place \$30,000 per month into an account held within the Library Construction Fund in the same proportions as identified above in Section 3 of this Agreement (City \$12,300.00/District \$17,700.00). Such funds shall be used for the purpose of acquisition, designing, and constructing the New Library.

B. All other provisions in the Agreement remain unchanged.

Contract of Employment: Library Director

An agreement made this day January 1, 2019, between the Board of Trustees of the Central Skagit Rural Partial County Library District, hereinafter known as the "Library Board," and Jeanne Williams, hereinafter known as the "Library Director."

The parties agree to the following terms:

- 1. The contract is effective for a one-year term beginning January 1, 2019 through December 31, 2019.

- 5. The Library Director will be compensated with an annual salary of \$94,760, effective January 1, 2019.
- 6. All other conditions of employment apply as outlined in the District Personnel Guidelines.
